

## PRIVACY POLICY

PWV Insurance Brokers values the importance of protecting your personal information and we subscribe to the principles as outlined in Section 51 of the Electronic Communications and Transactions Act 2002.

### 1. PERSONAL INFORMATION

Personal information, for the purpose of this document, means all information specific to you, which is provided to PWV Insurance Brokers online – in other words, information that identifies you. This includes for, example, the following personal information that you may provide to PWV Insurance Brokers:

- 1.1 your name and surname;
- 1.2 age;
- 1.3 marital status;
- 1.4 identity number;
- 1.5 date of birth;
- 1.6 email address; and
- 1.7 contact number(s).

PWV Insurance Brokers values the information you choose to provide and that which we collect from you, and will take reasonable steps to protect your personal information from loss, misuse or unauthorised alteration. In terms of legislation, information will be provided to your insurer. Information relating to you is stored in databases that have built-in safeguards to ensure the privacy and confidentiality of that information. Please note, however, that PWV Insurance Brokers cannot guarantee the security of any personal information that you disclose online.

Whenever you use this website, complete a quotation or application form or contact us electronically, we will process and collect your personal information.

PWV Insurance Brokers will use your personal information only as appropriate in the normal course of business. The following are reasons why we would collect your personal information:

- 1.1 to identify you;
- 1.2 to process your instructions to us;
- 1.3 to manage your policy/ies;
- 1.4 compliance with the laws of the Republic of South Africa;
- 1.5 detecting fraud; and/or
- 1.6 direct marketing to you via email or telephone.

PWV Insurance Brokers does not permit the selling or providing of personal information to third parties for independent use. At PWV Insurance Brokers we may, however, share your personal information with our partners if that information is required to provide you with the product or services requested by you. Our business partners will adhere to using your personal information as directed by PWV Insurance Brokers.

We will disclose your personal information when required to do so:

- 1.7 by any regulatory authority (such as the Financial Services Board) for the various financial sectors;
- 1.8 to comply with any regulation passed under relevant legislation, or any legal process;
- 1.9 to protect and defend PWV Insurance Brokers' rights and property (including PWV Insurance Brokers' intellectual property); or
- 1.10 when you have expressly authorised PWV Insurance Brokers to do so.

We may also contact you about our products which we believe may be of interest to you. If at any stage after you have given us your consent, you change your mind and no longer wish us to contact you about our products, we will respect your decision. You will always be given the opportunity to instruct us to remove your contact details from our mailing list.

You have the right to access your own personal information that PWV Insurance Brokers keeps about you by following the procedures available under PWV Insurance Brokers' Promotion of Access to Information Act manual available from PWV Insurance Brokers' website.

## **2. ONLINE ADVERTISING**

PWV Insurance Brokers engages third parties that help it deliver its banner advertisements and other online communications.

The third parties may collect and use information about PWV Insurance Brokers' customers that is limited to web browser behaviour to help us understand the offers, promotions, and types of advertising that are most appealing to its customers. The information they collect is aggregated and cannot be linked to a person or any specific information about that person.
